PRIVACY POLICY

OUR PRIVACY COMMITMENT

FIRM NAME ("we," "our," or "Company") is committed to respecting the privacy rights and concerns of all users ("Users") of Company's websites and services ("Website"). As such, we have established and implemented this Privacy Policy ("Privacy Policy") to inform Users how we use and protect the personal information we collect ("Personal Information").

By visiting or using the Website or the services offered through the Website ("Services"), you consent to Company's collection, use, storage, deletion, and disclosure of information relating to you as set forth in this Privacy Policy. This Privacy Policy is subject to change at any time for any reason and without notice. Any modifications will take effect when posted. Therefore, each time you access the Website, you need to

COOKIES

WEB ANALYSIS TOOLS

We may use web analysis tools to measure and collect anonymous session information. We use this information to monitor and analyze in a depersonalized form how users use the Website, to provide customers with the Website, and to maintain and improve the Website. We may also collect similar information from emails we may send to you which then help us track which emails are opened and which links are clicked by recipients. THIRD PARTY PIXELS AND COOKIES

When you visit our Website, log in or register, or open an email from us, cookies, ad beacons, and similar technologies may be used by our online data partners or vendors to associate these activities with information they or others have about you, including your email address. We (or service providers on our behalf) may then send communications and marketing to these email addresses. You may opt out of receiving this advertising by visiting websitename.com/opt-out

USE OF PERSONAL INFORMATION

We use your personal information to provide the Website to you, deliver products and services you request, handle your questions or issues, and send communications to you about promotions, updates, or special offers that may be of interest to you. We will also share the personal information we collect from you under the following circumstances:

Feedback. You may choose to, or Company may invite you to, submit comments, bug reports, ideas, or other feedback about the Website ("Feedback"). By submitting Feedback, you agree that Company is free to use such Feedback at its discretion without any obligation to you. Company may also choose to disclose Feedback to third parties. You hereby grant Company a royalty-free, perpetual, irrevocable, transferable, sublicensable, worldwide, nonexclusive license under all rights necessary to incorporate and use your Feedback for any purpose.

Asset Transfers. If we become involved in a merger, acquisition, or other transaction involving the sale of some or all of Company's assets, User information may be included in the transferred assets. Should such an event occur, we will use reasonable means to notify you through email and/or a prominent notice on the Site.

THIRD PARTY SERVICES' PRIVACY POLICIES

Should you file any arbitration claims or any administrative or legal actions without first having attempted to resolve the matter by mediation, then you agree that you will not be entitled to recover attorneys' fees, even if you would otherwise be entitled to them.

Residents of California may have the following rights:

- 1. Right to know and access your personal information. Under CCPA, you have the right to: Know the categories of personal information we collect and the categories of sources from which we got the information;
 - Know the business or commercial purposes for which we collect and share personal information; • Know the categories of third parties and other entities with whom we share personal information; and • Access the specific pieces of personal information we have collected about you.

- 2. Right to deletion. In some circumstances, you may ask us to delete your personal information. To do so, send us a request and include your name, email address, phone number, California postal address as well as your subscription account number, if you have an active subscription.

Authorized Agents

For any of the CCPA rights, you may designate an authorized agent to make a request on your behalf. In the request, you or your authorized agent must provide information sufficient for us to verify the identity of your agent and that your agent has been properly authorized to act on your behalf; this may take additional time to fulfill your request. If you are an authorized agent working on behalf of a consumer, you will need to fill out the relevant CCPA request form listed above on behalf of the consumer with the consumer's information. Please note that the consumer you are working on behalf of must have a California postal address and will need to verify access to the email account used to submit the CCPA request in order for us to move forward with processing the request.

Minors

ADDITIONAL TERMS AND PRIVACY POLICY FOR EU CITIZENS

Under the General Data Protection Regulation (GDPR) of the European Union (EU), EU citizens are entitled to certain privacy protections regarding the use of, storing, and processing of your personal information as well as having right to be notified if personal information is stolen, copied, or accessed on an unauthorized basis.

The GDPR is a modern privacy rights framework adopted to create better transparency and control over who, how and when your personal data may be used, including the "right to be forgotten".

OUR BUSINESS
